to be co-applicant/partner in a proposal submitted by a Municipality or a Union of Municipalities?	applicant/partner. Nevertheless, we strongly encourage collaborations in the identification of project's ideas in order to build synergies with INGO and local NGO running programmes.
Eligibility of applicants: criteria (3) The applicant must be located in at least one of the 251 most vulnerable cadastres identified in the Inter-agency vulnerability map <u>https://reliefweb.int/sites/reliefwe</u> <u>b.int/files/resources/27032015_Vul</u> <u>nerabilityMapMarch2015.pd</u>	In reference to the applicant eligibility criteria (3), please note that even if the majority of cadastres are equal to a single municipality, some cadastres are subdivided into multiple municipalities and one municipality could be composed by more than one cadastres. As a conclusion, the shared vulnerability map reflects 251 cadastres and even a higher number of affected municipalities therefore, all municipalities falling within the boundaries of the listed 251 cadastres and satisfying the remaining two eligibility criteria ⁱ will be considered eligible applicants.

Is there any template?	 In reference to Annex D, Part 1 (Administrative) Point 7 "Evidence of the representative's authorization to act for and on behalf of the Applicant is included": If the main Applicant is a single municipality: in case that the Authorized Representative is the Mayor, it is required to submit the signed minutes of the selection of the mayor by the municipal council members; in case that for any reason the mayor is not available, it is required to submit the signed minutes of the municipal session stating the reason of the absence of the mayor and the name of the member appointed as legal representative.

	list of the municipalities members of the cluster and the name of
	the legal representative of the cluster.
